We are writing to provide an update on some changes the MOJ is preparing to make to the procedure to become an MOJ accredited lab to undertake Section 20 paternity tests and what it means for you.

We will be making some changes to the application process with the aim of simplifying the procedure. We hope that these changes will be in place later in 2021.

Please note, the intended changes will not dramatically alter the current process or what is required from you, and thus minimal effort should be required to adapt to these changes.

As a result of these changes, the MOJ will automatically extend your accredited status from 31st August 2021 until January 31st 2022. Furthermore, you will **not** be required to send in an application renewal form, as would normally be the case, for summer 2021.

We will contact you further in late 2021 to outline the simplified process, and what you need to do in order to renew your accredited status for 2022.
